Registration and Onsite Check-In Online Registration

There is no registration fee to attend the Constitutional Convention. **The registration deadline is July 26**, **2025 at 5:00 p.m. ET.**

When registering delegates, please ensure each delegate has a unique email address. Upon registration, a follow up email will be sent to the delegates to facilitate self identification for any of the following equity caucus meetings:

- Young Workers

- Black, Indigenous and Workers of Colour

Delegate Entitlement

Article 6.B.3 - Composition of Convention

Delegate Entitlement shall be based on the following:

a. Single Unit Local Unions or Subordinate Bodies

1 to 250 members	1 delegate
251 to 500 members	2 delegates
501 to 750 members	3 delegates
751 to 1,000 members	4 delegates
1,001 to 1,250 members	5 delegates

And one additional delegate for each additional 250 members.

b. Amalgamated Local Unions or Subordinate Bodies

Each bargaining unit with 250 members or more of an amalgamated Local Union shall have delegate entitlement based on the following:

250 to 500 members	1 delegate
501 to 750 members	2 delegates
751 to 1,000 members	3 delegates
1,001 to 1,250 members	4 delegates

And one additional delegate for each additional 250 members.

Members of bargaining units within an amalgamated Local Union with fewer than 250 members shall be grouped together and entitled to delegates as per Section B, Paragraph 3a. of this Article.

Article 6.B.5

Each Local Union and subordinate body shall provide the Secretary Treasurer with delegate registrations no later than 30 days prior to the opening of Convention, including the names, home addresses, email addresses of each delegate, alternate delegate or special delegate, and the identity of the Chairperson of the delegation.

Article 6.B.7

Delegates and alternate delegates to convention shall be elected by secret ballot with a minimum of 15 days notice to all members of nominations and elections. Candidates with the most votes shall be elected, unless the By-Laws of the Local Union stipulates otherwise.

Industry Council Meetings

If your Industry Council is meeting in Vancouver prior to the start of the Constitutional Convention, you will be notified directly by your Industry Council.

Registering for your Industry Council meetings DOES NOT register you for the Constitutional Convention.

Locals participating in Industry Council meetings will receive direct notice.

Resolutions & Constitutional Amendments

The following outlines the rules about Resolutions and Constitutional Amendments.

Article 6, Section C - Resolutions and Constitutional Amendments

- 1. Resolutions and constitutional amendments proposed by Local Unions or subordinate bodies must be approved by a membership meeting, signed by a Local Union Officer and submitted to the Secretary-Treasurer no later than 90 days prior to the opening of Convention.
- 2. The National Executive Board may submit resolutions or constitutional amendments approved by a majority vote of the National Executive Board.
- 3. The Secretary-Treasurer shall circulate to all Local Unions and subordinate bodies all resolutions or constitutional amendments no later than 60 days prior to the opening of Convention.

What is the process for submitting a Resolution or a Constitutional Amendment?

- Resolutions and constitutional amendments must be submitted by **Tuesday**, **May 27**, **2025 at 5:00 p.m. ET.**
- Each resolution or constitutional amendment must be approved by the members at a membership meeting, include the date of the meeting when it was approved, and must be signed by a Local Union Officer.
- Resolutions and constitutional amendments must be submitted by email and will be accepted as long as the deadline date is respected and each resolution and amendment bears the required approval and signatures.
- Please submit resolutions and constitutional amendments only once. It is not necessary to mail the original if your submission has already been emailed with the required signatures.

Resolutions

Resolution submission must use the clear language format and include the following:

- Explain why your local is submitting the resolution;
- Explain what your local wants Unifor to do or not do;
- Be no longer than 200 words;
- Cover new issues or change current policies;
- Cover only one main issue per resolution;
- Use sentences that are clear, direct, and short;
- Use words that readers will easily understand;
- Be specific. Explain what you want to happen.

- Clearly identify what article is to be amended and include the text of the Article in the current Constitution;
- Indicate whether the amendment is to: add, delete, or make changes;
- Emphasize the change to the Article, paragraph, or subparagraph.

Child Care, Shuttle Service & Accessibility

Child Care

Child care will be provided during the business hours of the Constitutional Convention. To be accepted into the program, children must be registered by the deadline - July 26, 2025 at 5:00 p.m. ET.

Drop off and pick up information:

- All children must be signed into and out of the program each time they leave their group.
- Please respect the hours of child care and have your child/children picked up at the specified time.
- Your child/children must be registered by the deadline to secure a spot and won't be accepted into the program after July 26, 2025.

What to bring each day:

- Children 3 and under: formula, infant food (if required), diapers, wipes, extra change of clothes, blanket/cuddle item (for naps if they are accustomed to a security object).
- Children 4 and older: running shoes, rain coat/umbrella, swimsuit.

Election & Important Dates

Election

The upcoming Constitutional Convention will include elections for the following positions:

- National President
- National Secretary-Treasurer
- Québec Director*
- Western Regional Director
- Ontario Regional Director
- Atlantic Regional Director

*During the Constitutional Convention, a motion to affirm the election of the Quebec Director by the Quebec Council shall be placed before the delegates following the election of the President and the Secretary-Treasurer.

The National Executive Board has adopted an Election Code that will apply to the election of National Officers and Regional Directors at this Convention. That Election Code permits a candidate to declare their candidacy after the date of this call letter. Declared candidates must affirm that they will comply with the Election Code. The Election Code reminds candidates of the high standards of ethics, democratic practice and ethical conduct that are demanded by our Constitution. It regulates election campaign finances and donations and limits the participation of Unifor employees in election campaigns. It also prohibits employer donations.

A member that declares that they will be a candidate for National Officer or Regional Director may make their declaration by any means but must at the same time deliver a statement of their declaration and their affirmation that they will adhere to this Election Code to <u>elections@unifor.org</u>
