## **ENTITLEMENT AND ELECTIONS**

#### **DELEGATION DESIGNATIONS**

Delegates are the only members of the delegation to get voice and vote at Council. Each local has a limited number of delegates based on the following calculations:

- local unions with 1 to 250 members = 1 delegate
- local unions with 251 to 500 members = 2 delegates
- local unions with 501 to 750 members = 3 delegates
- local unions with 751 to 1,000 members = 4 delegates
- local unions with 1,001 to 1,250 members = 5 delegates

Plus one additional delegate for each additional 250 members.

For additional information including information on amalgamated local unions, please review the BCRC Bylaws.

Special Delegates have voice and no vote at Council. This category may include members of your Standing Committee Executive, unit chairs or members of an equity seeking groups (BIWOC, Young Workers, Workers with DisAbilities, LGBTQ or Women.)

Observers have no voice or vote at Council and may be members who do not qualify as special delegates. Locals may register multiple observers.

#### **ELECTIONS**

Elections for the remainder of the 3 (three) year term will be held for the following positions:

- Secretary Treasurer (1)
- Women's Standing Committee (1)

Vacant positions for the Equity Standing Committees will be filled by peer election during their designated equity caucus. Please refer to your council agenda at registration for caucus times and dates. For information on duties related to Council Executive officers and Standing Committee positions, please refer to your BC Regional Council Bylaws.

Please note: nominees should ensure they have the support of their Local President prior to accepting a nomination. The home locals of members of the BCRC Executive and Standing Committees must commit to financial support for the term, including costs associated with sending you to BCRC as part of their delegation.

## **RESOLUTIONS**

#### **GENERAL RESOLUTIONS**

General resolutions to be considered by the BC Regional Council must be received no less than 15 days prior to the opening of council.

The general resolution deadline is November 14, 2024. We encourage you to send your resolutions prior to this date. Delegates are entitled to be on the resolutions committee. If you would like to be considered for the resolutions committee, please email Teri.Roland@unifor.org.

#### **BYLAW AMENDMENTS**

In accordance with BCRC Bylaws, Article 9: Amendments:

The Bylaws of the Regional Council may be amended by a 2/3 majority vote to approve a resolution of a local union or a recommendation of the Executive Committee provided that all local unions have been given 30 days notice of a resolution or recommendation to amend the Bylaws.

To comply with Article 9, any resolutions pertaining to Bylaw amendments must be submitted no later than October 26, 2024. Locals would then be given notice no later than October 28, 2024.

Please refer to the sample resolution included in this package for a clear explanation of how to compose your resolution.

Tips for making resolutions clear for everyone to understand:

- Cover only one main issue per resolution.
- Use sentences that are clear, direct and short.
- Use words that your readers will easily understand and avoid jargon, abbreviations and acronyms.
- Be specific. Explain what you want to see happen. What you want to change, how you want it done, who you want to do it, and when you want it to happen.

IMPORTANT INFO: The Sea to Sky highway is a mountain highway, where conditions can be unpredictable due to rapid changes in elevation and weather. A trip that starts in sunshine may also encounter slush, ice, heavy snowfall or compact snow. For safety in winter conditions, passenger vehicles are required to have winter tires installed to drive on the Sea to Sky between October 1 and March 31.

- Snow Tires (3 peaked mountain and snowflake symbol)
- M & S Tires (tires rated for Mud Snow, usually all season)
