REGISTRATION

Delegate entitlement will be sent in a separate email to local union presidents. As the head of the delegation, it is the president or their designate's responsibility to register all members the local delegation.

To register for multiple events, please log out and log back in to select the next event on the home screen.

Locals are strongly encouraged to register a full delegation, including delegates, special delegates representating equity, and observers.

Equity Caucus Registration

Once your delegation has been registered with a unique email address, the participant will receive an email to self-identify and register for the Equity Caucus Meetings. If they do not receive the email, please contact Teri.Roland@unifor.org.

Important Notes

Current members of the B.C. Regional Council Executive must be registered as a delegate from the local. B.C. members that wish to run for the Council Executive or the Health, Safety and Environment, EFAP, or Political Action Standing Committees must also be registered as delegates of the local.

Individuals who wish to run for a position on an equity standing committee can be registered as a local delegate or special delegate. This only pertains to Women, BIWOC, LGBTQ, Workers with DisAbilities, and Young Workers (35 years and under)..

ENTITLEMENT AND ELECTIONS

DELEGATION DESIGNATIONS

Delegates are the only members of the delegation to get voice and vote at Council. Each local has a limited number of delegates based on the following calculations:

- local unions with 1 to 250 members = 1 delegate
- local unions with 251 to 500 members = 2 delegates
- local unions with 501 to 750 members = 3 delegates
- local unions with 751 to 1,000 members = 4 delegates
- local unions with 1,001 to 1,250 members = 5 delegates

Plus one additional delegate for each additional 250 members.

For additional information including information on amalgamated local unions, please review the BCRC Bylaws.

Special Delegates have voice and no vote at Council. This category may include members of your Standing Committee Executive, unit chairs or members of an equity seeking groups (BIWOC, Young Workers, Workers with DisAbilities, LGBTQ or Women.)

Observers have no voice or vote at Council and may be members who do not qualify as special delegates. Locals may register multiple observers.

ELECTIONS

In accordance with council bylaws, following a Constitutional Convention, BCRC must elect all positions for the next 3-year term. Positions to filled as follows:

- Chairperson (1)
- Vice Chairperson (1)
- Secretary-Treasurer (1)
- Member-at-Large (4)
- EFAP Standing Committee (3)
- Political Action Standing Committee (3)
- Health, Safety and Environment Standing Committee (3)

Equity Standing Committees

- Women's Standing Committee (3)
- BIWOC Standing Committee (3)
- LGBTQ Standing Committee (3)
- Workers With DisAbilities Standing Committee (3)
- Young Workers Standing Committee (3)

NOTE: Equity Standing Committee positions will be filled by peer election during their designated equity caucus meeting. Please refer to your council agenda upon registration for caucus dates and times. Elections happening on the floor of council will take place Saturday, October 25. Registration and changes to delegate status will be closed one hour prior to voting.

Formal nominations for the BCRC Executive and Standing Committees will take place during the Council. As per our bylaws (Article 5: Elections):

...a delegate nominating another delegate may make a brief statement, and all candidates shall have an opportunity to address the delegates.

Please note: nominees should ensure they have the support of their Local President prior to accepting a nomination. The home locals of members of the BCRC Executive and Standing Committees must commit to financial support for the term, including costs associated with sending you to BCRC as part of their delegation.

RESOLUTIONS

RESOLUTIONS

Resolutions to be considered by the BC Regional Council must be received no later than 15 days prior to the opening of council.

The resolution deadline is October 9, 2025. Delegates are entitled to be on the resolutions committee. If you would like to be considered for the resolutions committee, please email <u>Teri.</u> Roland@unifor.org.

BYLAW AMENDMENTS

In accordance with BCRC Bylaws, Article 9: Amendments:

The Bylaws of the Regional Council may be amended by a 2/3 majority vote to approve a resolution of a local union or a recommendation of the Executive Committee provided that all local unions have been given 30 days notice of a resolution or recommendation to amend the Bylaws.

To comply with Article 9, any resolutions pertaining to Bylaw amendments must be submitted no later than September 22, 2025. Locals would then be given notice no later than September 24, 2025.
