

## The Role of Unifor's Health and Safety Department

The Unifor Health, Safety and Environment (HSE) department is responsible for and provides the content of health and safety-training programs, campaigns for better laws and enforcement, and provides information on workplace substances and programs to eliminate and control hazardous workplace conditions.

This department also helps local unions set up programs to eliminate hazardous conditions in the workplace and assists local union leadership and national representatives to conduct health and safety training programs.

#### Our work includes:

Building enthusiasm within the union for HSE culture; motivating our rank and file members by engaging and energizing activists, reaching out to the members and increasing understanding for hazard prevention.

Providing guidance and leadership for the union on all Health, Safety and Environment (HSE) issues including advising the Officers of the Union about issues and ideas for action.

Helping to prepare the union for the future by working to expand our leadership capacity among as diverse and broad a membership base as possible.

#### **Across Canada**

Working within all provinces and our Regional Councils from across the country to discuss HSE issues and build activism from within. We build leadership capacity through our education and training programs.

We work closely with all departments, locals, staff and activists to promote Health, Safety and the Environment specifically, this includes:

- Organizing and conducting HSE conferences, courses and training programs
- Conducting campaigns on HSE issues
- Assisting and advising staff and leadership with advice for collective bargaining, HSE complaints, concerns and issues
- Assisting with union-building campaigns, including Organizing


The department works closely with local union HSE committees, other unions and Labour Centrals in conducting HSE work, and reaches out to build strong relationships with community organizations engaged in this work.
