TWO IMPORTANT REQUESTS – TIME SENSITIVE

Greetings!

The introduction of a \$15 minimum wage and sweeping new labour legislation has been an exciting development over the last month for our province.

Our union is working to ensure local leaders are informed about what this legislation means and what our next steps are. The Fair Work, Better Jobs Act (Bill 148) was introduced on June 1 and passed through first reading. This now means it is at the committee stage, which gives us an opportunity to push for further improvements. *Attached here you'll find a primer on Bill 148*.

I want you to know that this is not yet a done deal. Just as we can push to strengthen the legislation, we can also lose ground during the committee process before it goes to second reading in the fall. This is why I am contacting you today.

I'm writing ask you to do two things:
