Hospital Bargaining Strategy Session



Chair people, local union leadership and national staff

representatives representing Ontario hospitals met in Toronto December 9th and 10th to review past bargaining and plan strategy for negotiations that will commence in 2014.

In the most recent round of bargaining, three hospitals were successful in negotiating a three year agreement, resulting in a 2.75% increase in the final year. Other hospitals refused to negotiate a third year, and under the legislation that governs their collective bargaining, the Hospital Labour Dispute Arbitration Act, or HLDAA, the maximum term that can be awarded is two years unless the parties agreed otherwise.

Assistant to the President, Deb Tveit reported that for obvious reasons none of the hospitals would agree to a third year. "They were being cautious, and were fairly confident arbitrators would only award the mandated 2 year wage freeze, which was the case."

"The previous round of bargaining saw employers coming after sick leave plans, and the bargaining committees were very determined to resist that." Tveit adds, "We were able to hold onto our full sick leave plans without the concessions that some other unions had. The committee was very determined to not lose anything, so on that front it was successful."

The meeting included an economic overview of the provincial economy with a discussion about the impact of a possible spring election. Ontario Regional Director, Katha Fortier noted that all of the participants recognized the importance of getting into bargaining as quickly as possible. "Everyone committed to holding proposals early in the new year and sending notice to bargain early. Members are clearly focused on monetary gains this round and to do that we will need to go in fast and early, and organize what is happening at all tables."

There will be a master group within the northern hospitals. Other hospitals will bargain individually, but efforts will be coordinated through the national union.

2014 Health Care Conference

Assistant to the President, Deb Tveit explains that the theme is two-fold because of the many challenges we are facing. "Federally we must do more to pressure the government to renew the health accord so that the provinces have the resources they need to continue to provide services, especially in our hospitals. And all workers, including health care, are at risk of having their hard fought labour rights taken away from them."

Cape Breton Supports Veterans

Members from health care Locals 4300 and 4306 were highly visible at a November rally at the Royal Canadian Legion in Sydney, NS to show their displeasure with the federal government's decision to close several offices across the country.

Susan Gill, President of Local 4600 said "veterans need to be shown the respect and the dignity that they have earned serving our country; attempting to balance a budget with cuts to veterans is shameful and should not happen."

With the Sydney office scheduled for closure next year, veterans will have to travel five hours to Halifax for services. Supporters marched with the veterans singing O Canada, and chanting "lest we forget".

Local 229 Rally's at St. Joseph's Hospital



More than 100 Unifor Local 229 members and supporters participated in an information picket outside St Joseph's Hospital in Thunder Bay on Friday January 17, 2014.

The purpose of the rally was to highlight issues identified by members surrounding increased workloads, management

compensation in the era of wage freezes, redeployment of staff, job security and serious workplace injuries.

President of Local 229 Kari Jefford states: "every day we have members reporting serious injuries and fatigue. They are all doing their very best to serve patient's needs, support families and community groups at what I feel, is a detriment to them. Our members work short, have huge workloads and large amounts of stressors in their work lives. They do their jobs with incredible care and compassion putting their patients and their families first. They are looking to their union for support and we are here to support them."

Assistant to the President Deb Tveit who attended the rally noted that "In the past two years our workers, have taken a two year wage freeze but their workloads are increasing, work stress is multiplying causing injuries and some members report they have lost their passion for the work that they do. The top administration have taken wage increases stating that the legislation allows them to do that. Alongside the frontline staff's zero wage increase it makes it difficult for members to see how this is fair."

Tveit adds, "Healthcare in Ontario and in Canada is under attack. We as Ontarians and Canadians need to educate ourselves politically in order to understand what is at stake for us in the comings months and years."

Taking the SAFER Campaign Public

Staffing Alliance for Every Resident, or SAFER, continues to plan strategy to push the government to implement an evidence-based, minimum, measurable, enforceable standard of care in our nursing homes.

The coalition, which includes partners Tamara Daly, Associate Professor and CIHR Research Chair, Paul Tuttle, President of Extendicare, and Jane Meadus, Institutional Advocate with the Advocacy Centre for the Elderly, will bring their campaign to the public in February. Ontario Director Katha Fortier, reports that there will be a series of events that will include the launch of a web page, and a Queens Park press conference. "Our unlikely coalition itself is attracting attention and so we are ready to take this next step, after making our case to the Minister of Health and several ministry officials. We've seen far too many preventable tragedies in our homes. We all believe, that with appropriate staffing levels, nursing homes can become a safe, and even a desirable haven for people requiring care."

SAFER submitted a proposal to the Finance Minister as part of their pre-budget consultations in January.

Ontario Health Care Leadership Meeting

Unifor President, Jerry Dias met with 200 workplace leaders, local union executives and national staff representatives on January 22nd in Toronto, for a day of dialogue and evaluation.

Dias states "Health care is not only our largest sector in the province, but the services they provide are critical to all our members and to every single person in the province. We want to make sure we are crystal clear about a communications strategy that includes making sure we are offering this unique sector every support we can."

The meeting concluded with constructive suggestions for ensuring Unifor is highly visible in the sector, and lines of communication are open. Assistant to the President Deb Tveit committed whatever resources are needed. "Developing



leadership and supporting the education and training needs will build strong locals to create a strong and progressive union. We can continue to strengthen our publication "The Pulse" but will add other tools like a new member orientation kit and social media options."

National Day of Action to Mark the Expiry of the 2004 Health Accord

The Canadian Health Coalition, along with their partners are planning a national day of action March 31, 2014, to mark the expiry of the 2004 Health Accord, that allowed for steady, and consistently increasing transfer payments from the Federal Government to the provinces to provide services.

Ontario Regional Director, Katha Fortier who sits on the CHC board states that this issue should be critical to every single Canadian who values our public health care system. "It's clear that the Harper government has no desire to even discuss this with the provinces, and they've given every indication that they do not intend to support, let alone enforce the Canada Health Act.

Registered Practical Nurses to Lobby Queens Park

In follow-up to the Ontario RPN meeting last October, a lobby day at Queens Park has been set up for Monday March 3rd. Participants will be asked to come into Toronto for training the afternoon prior, and meetings will be pre-arranged for them to meet directly with MPP's to discuss the value of an RPN. "Who best to describe the impact that RPN's have in our health care system then a practicing nurse" says Kelly-Anne Orr, RPN, and now national staff representative, who is coordinating the lobby. "They are an articulate group, and know their roles, and can convey that to MPP's who in all likelihood have no idea what they do."

Notice of the meeting has been sent to health care local unions who are being asked to send at least two RPN's to the lobby. For more information contact your local union.
